The five voting stations, clearly marked with the numbers 1 to 5, are situated in Room A.

Delegates are requested to use the felt-tip pen distributed with the ballot paper when completing the ballot paper, and to follow the instructions provided with the ballot paper in order to avoid submitting an invalid ballot.

The Secretary of the Plenary will call the names of the delegations in the five sectors in groups of fifteen at a time in French alphabetical order. When called, delegates (one per delegation) are

requested to proceed to their designated voting station (see lists above), identify themselves to the ITU officials at that voting station, cast their ballots and return to their seats. Delegates should keep their felt-tip pens for use in subsequent elections.

The block in the bottom right-hand corner identifies the ballot paper for the computer as being part of a specific round of voting for each election, but does not permit any individual ballot paper to be identified.
