**REPORT OF COMMITTEE 2 TO THE PLENARY MEETING  
(CREDENTIALS)**

**1 Terms of reference**

The terms of reference of the Committee are described in Documents [2](#) and [93](#).

**2 Meetings**

The Committee held two meetings, on 21 and 29 October 2014.

At its first meeting, a working group, chaired by Mr Timofey KIM (Kazakhstan), Chairman of Committee 2, Mr Valmikki SINGH (Guyana), Mr Dmytro PROTSENKO (Ukraine), Mr Garry MUKELABAI (Zambia), Ms Duo LIU (China) and Mr Tareq ALSAIF (Kuwait), Vice-Chairs of Committee 2, was set up to verify the credentials, transfers of powers and proxies of delegations, in accordance with Article 31 of the ITU Convention.

**3 Meetings of the Working Group of Committee 2**

The Working Group of Committee 2 met twice, on 21 and 29 October 2014. Participants were able to consider in detail each of the credentials and transfers of powers deposited with the secretariat, with reference, in particular, to Article 31 of the ITU Convention. Credentials received by fax (or scanned copies by e-mail) were considered pending receipt of the original documents.

**4 Conclusions**

The Committee's conclusions are given in the Annex to this document and are submitted to the Plenary Meeting for approval.

**5 Closing remarks**

The Committee recommends that the Plenary authorize the Chairman of Committee 2, assisted by the secretariat of Committee 2, to verify credentials, transfers of powers and proxies received after the date of this report and to submit the Chairman's conclusions in that respect to the Plenary Meeting.
